COURSE DESCRIPTION

The prerequisite for this course is successful completion of Math 3100, Introduction to Mathematical Proofs, with a grade of C or better. Most of this course will be proofsoriented.

In this class we will introduce the elementary concepts of modern group theory and a little bit of ring theory. In more detail, course topics will include:

- modular arithmetic
- groups
- subgroups
- cyclic and permutation groups
- isomorphisms
- · Lagrange's theorem
- · direct products
- normal subgroups
- homomorphisms
- the fundamental theorem of finite abelian groups

• rings

The textbook for this course is *Contemporary Abstract Algebra*, 8th ed., by Joseph A. Gallian. We will cover the material in chapters 0 through 12.

THE EVERYDAY CLASS

Your presence in class is expected. In class, you are expected to pay attention and contribute. At the very least, you must not be a distraction to your fellow classmates. I intend to give three tests over the course of the semester. They are tentatively scheduled for the following dates: February 5, March 5, and April 9. Those dates are subject to change, though, particularly if bad weather interferes. No make-up exams will be given unless you can present a valid documented excuse. In this case, you will either take a make-up exam or be given a grade based on other assignments, whichever I feel is more appropriate. We will end the semester with a comprehensive final exam. If your final exam grade is higher than your lowest test grade, I will replace that lowest test grade with the final exam grade.

- No make-up exams will be given unless you can present a valid documented excuse. In this case, you will either take a make-up exam or be given a grade based on other assignments, whichever I feel is more appropriate.
- Your final exam grade may be used to replace you lowest test grade.
- At the end of the semester you will have a comprehensive final exam.
